Further, the petitioner shall appear before the trial Court on every first working day of every month at 10.30 a.m until further orders.

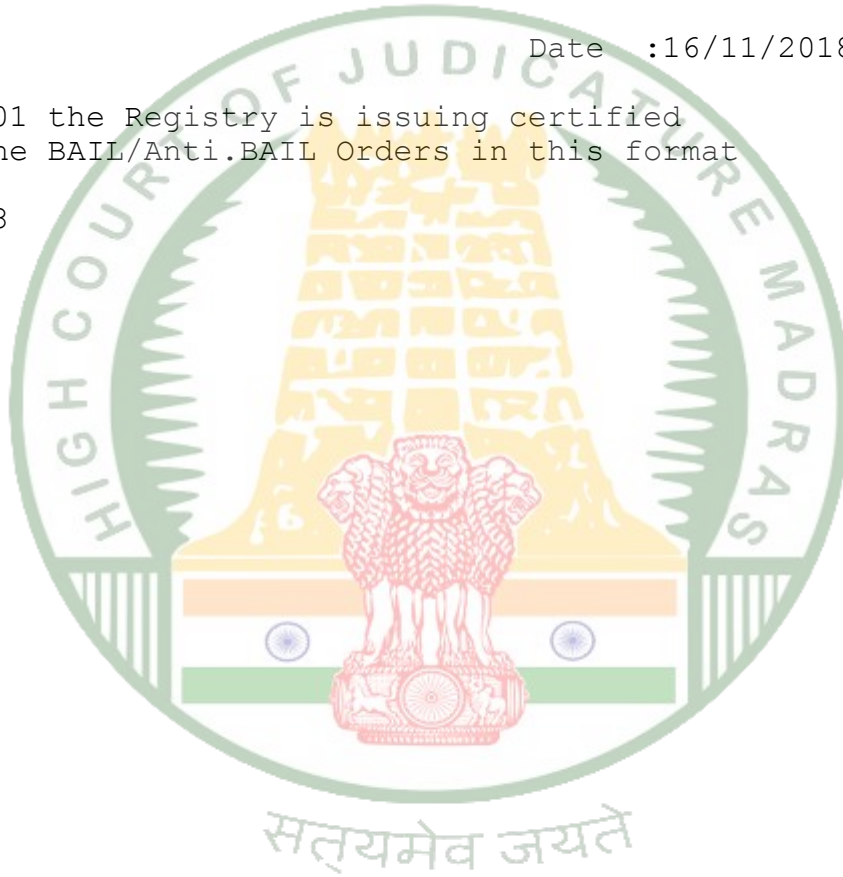
