PRAYER in W.P.No.27088 of 2018: Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the respondent to issue or publish the Hall Ticket for petitioners online application dated 30.07.2018, vide Application No.11811221 and a Demand Draft for a sum of Rs.600/- vide D.D.No.165894 dated 27.07.2018 drawn on Canara Bank, Tiruchendur Branch, based on the petitioner's covering letter with hard copy of online applications along with Original Demand Draft with a covering letter dated 05.10.2018 and to direct the respondent to permit the petitioner to write the said examinations to be held on 14.10.2018 & 15.10.2018 for the appointment to the post of Assistant Professor in the Government Law Colleges in Tamil Nadu.
