COMMON ORDER

2.This Writ Petition is disposed of by giving liberty to the petitioner to workout his remedy as and when any

individual complaints are made against the petitioner or the petitioner is put to harassment by any police in the name of enquiry, in spite of the petitioner possessing necessary qualification to practice medicine. Consequently, connected miscellaneous petitions are closed.

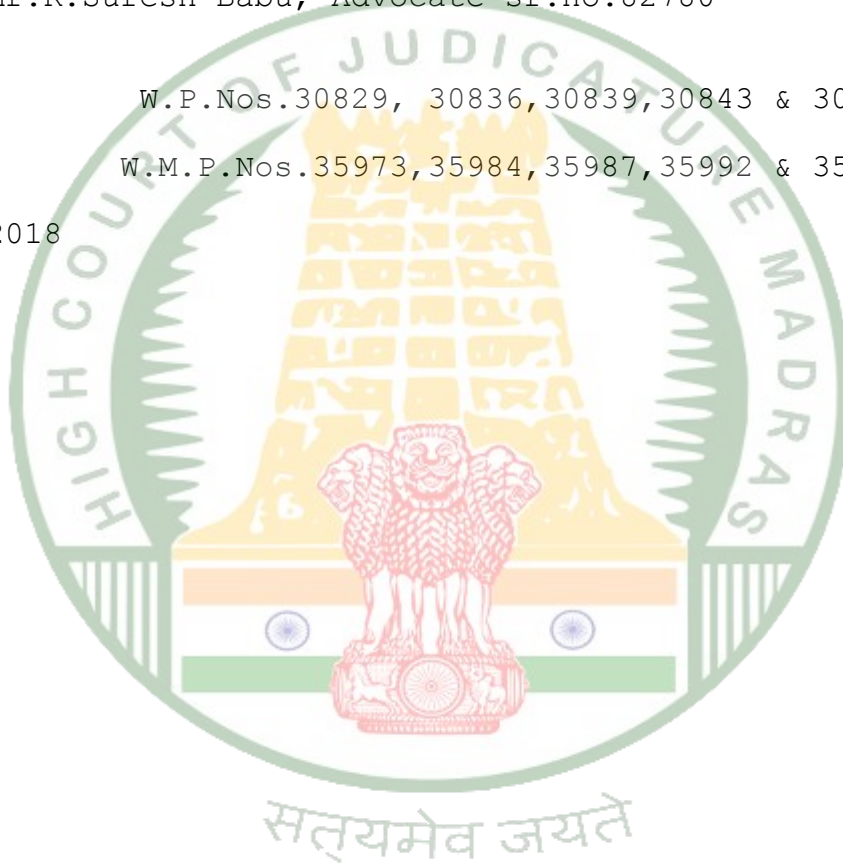
