Writ Petition filed under Article 226 of the Constitution of India, praying to issue a writ of Mandamus, directing the respondent to issue patta in the name of the petitioner for the land and building bearing Plot Nos.74 and 75, Kannadasan nagar 6th street, Ramapuram, Chennai-600 089, land measuring an extent of 4170 sq.ft., together with house building, comprised in Survey No.28/2 (part) and 28/2A1, as per patta of Ramapuram village, Ambattur Taluk, Tiruvallur District.

ORDER

By consent of both parties, the writ petition is taken up for final disposal at the admission stage itself.

2.The petitioner has come up with this writ petition seeking a direction to the respondent to issue patta in the name of the petitioner for the land and building, as per patta of Ramapuram village, Ambattur Taluk, Tiruvallur District.

3.According to the learned counsel for the petitioner, the petitioner has submitted a representation dated 09.07.2018 claiming the same relief as prayed in this writ petition, but, the same is yet to be disposed of by the respondent. Hence, the petitioner is before this Court.

4.Mrs.P.Rajalakshmi, learned Additional Government Pleader taking notice for the respondent, submitted that the respondent be directed to consider the petitioner's representation and pass orders in accordance with law.

5.Considering the facts and circumstances of the case and having regard to the submissions made by the learned counsel on either side, this Court directs the respondent to consider the petitioner's representation dated 09.07.2018 and pass appropriate orders, on merits and in accordance with law, after affording due opportunity of hearing to the petitioner as well as any of the interested parties, within a period of eight weeks from the date of receipt of a copy of this order.

6.Accordingly, this writ petition stands disposed of. No costs.
