ORDER

This writ petition has been filed challenging the validity of the proceedings of the 5th respondent dated 06.08.2018 in Na.Ka.No.241/208/A1 regarding putting up of cut and cover drain on the land belonging to the petitioner as a

precautionary measure to prevent the water logging in the streets situate within the respondent Municipality during rainy season.
