3. The learned Additional Public Prosecutor submitted that the petitioner is regularly complying with the condition imposed by this Court.

Taking into consideration the submissions made by the counsel on either side, the condition imposed on the petitioner in Crl.M.P.No.2238 of 2018 in Crl.A.No.94 of 2018 dated 16.02.2018 is modified to the effect that the petitioner shall appear before the learned Special Court Judge (Special Court for Trial Cases under the Prevention of Corruption Act), Salem once in two months on the first working day of the particular month at 10.30 a.m., starting from the month of December 2018.
