Registry is directed to return the original plaints to the learned counsel for the petitioners.

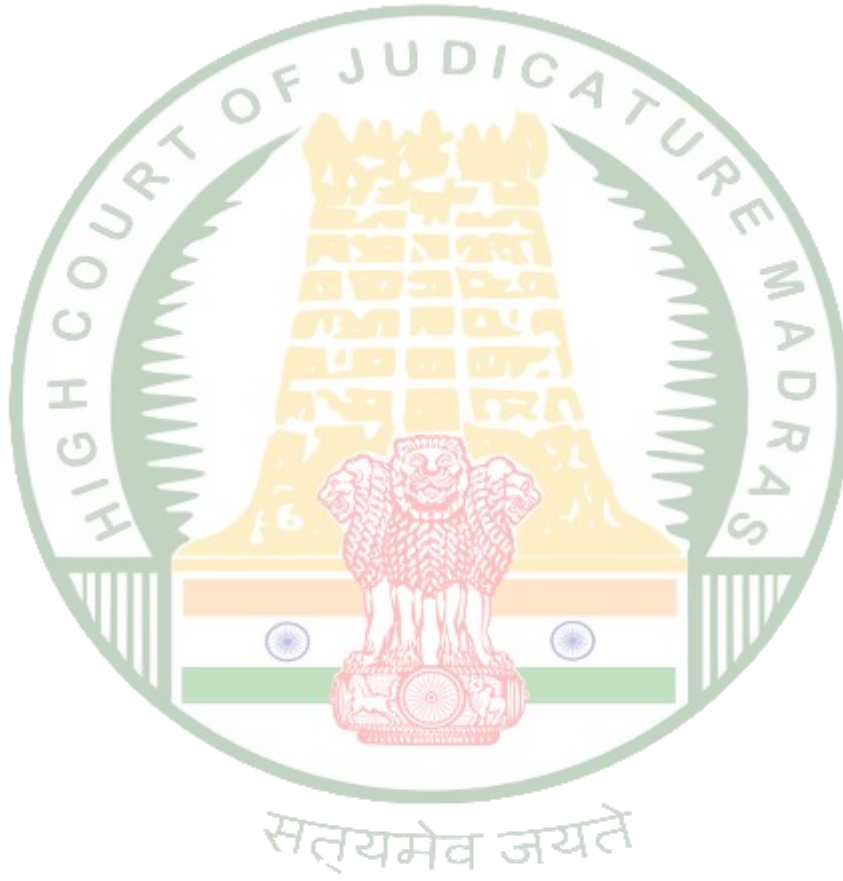
3. Accordingly, the Civil Revision Petitions stands disposed of. No costs. Consequently, connected Miscellaneous Petition is closed.
