O R D E R

This writ petition has been filed by the petitioner seeking directions to the respondent to consider the petitioner's representation, by which the petitioners has sought for the payment of terminal benefits.

2. Heard the learned counsel appearing on both sides.

3. The petitioner was appointed as a cashier in the year 1978 in the C-1703 Sholingar Milk Producers, Co-operative Society. In the year 2011, the petitioner was promoted as Deputy Manager and in the year 2013, he was promoted as General Manager and he reached the age of superannuation on 31.05.2017. But till date, the retirement order has not been issued by the President C1703 Sholingar Milk Producers Society. During the petitioner's tenure in the Society, there was neither misappropriation of funds nor any criminal action taken against him.

4. In view of the limited relief sought for, without dwelling into the merits or otherwise of the matter and considering the facts and circumstances of the case, this Court directs the respondents to consider the petitioner's representation dated 08.10.2018 and pass appropriate orders within a period of two (2) weeks from the date of receipt of copy of this order. Accordingly, the writ petition is disposed of. No costs.

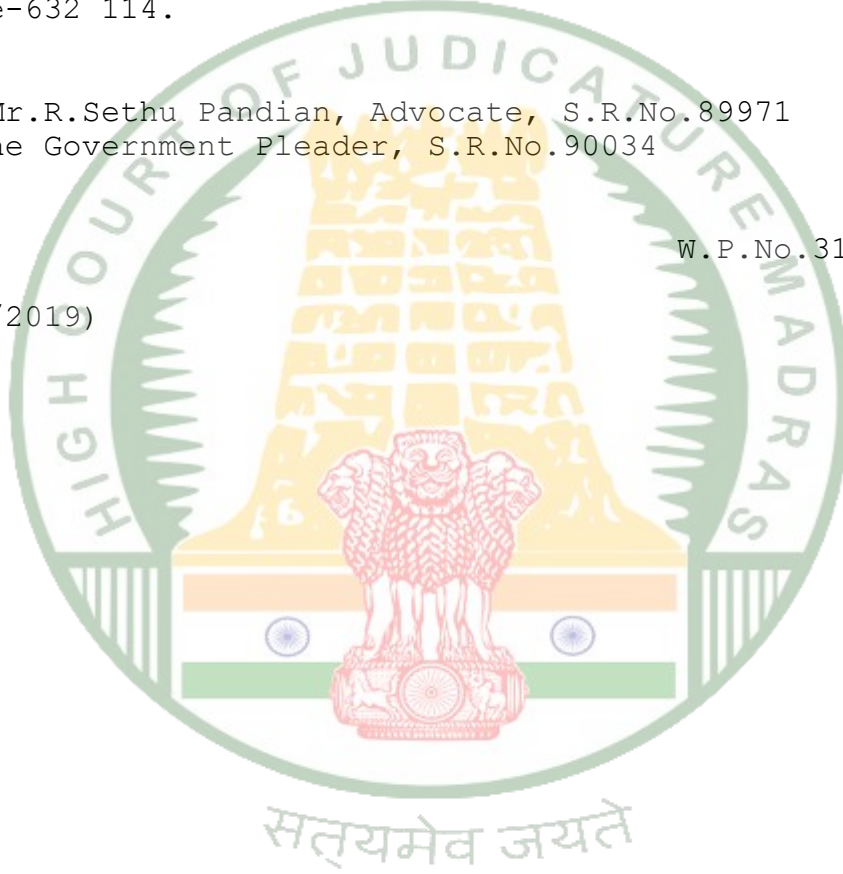
