District Judge, (Fast Track Court), Villupuram District in C.A.No.57 of 2016 on 05.09.2018, be suspended on condition that the petitioner shall deposit 50% of the amount as ordered by the Trial Court, within a period of four weeks from the date of receipt of a copy of this order.

2. The learned counsel for the petitioner would submit that already Rs.20,000/- had been deposited in the Appellate Court.

3. Therefore, the above said amount deposited in the Appellate Court, shall be given credit of while making the present deposit. Crl.M.P.No.15942 of 2018, is ordered accordingly.
