3. The case was originally pending on the file of the Judicial Magistrate No.I, Pudukottai and it was numbered as STC.No.30/2013. The petitioner is the complainant in the 138 complaint and the grievance of the petitioner is that the case is pending for more than five years.

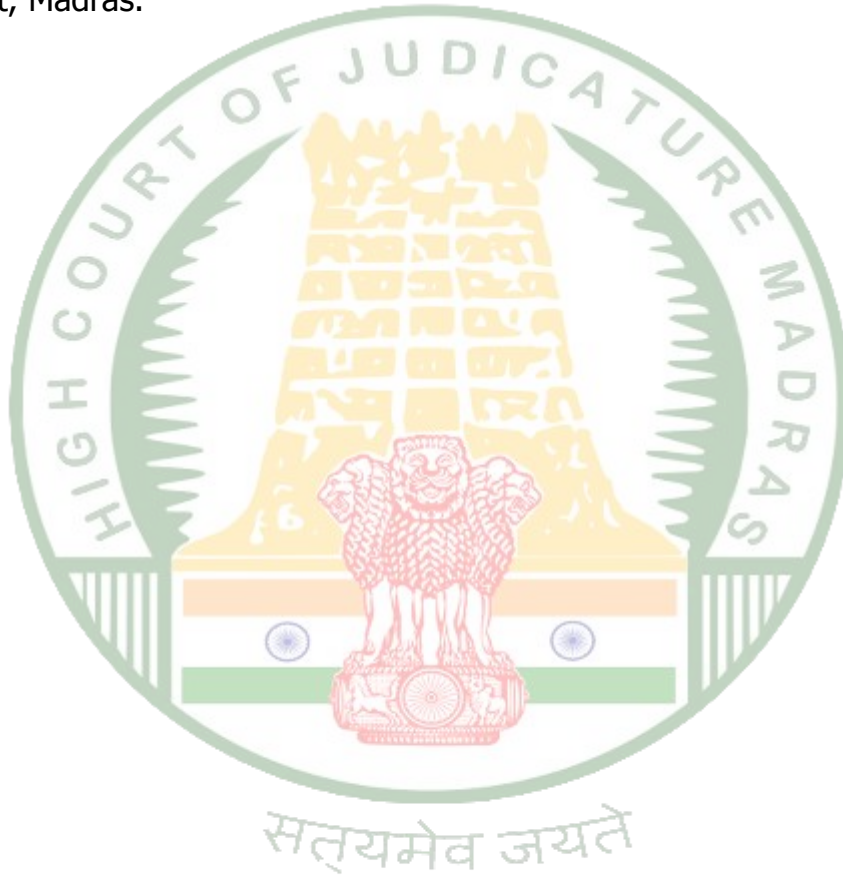

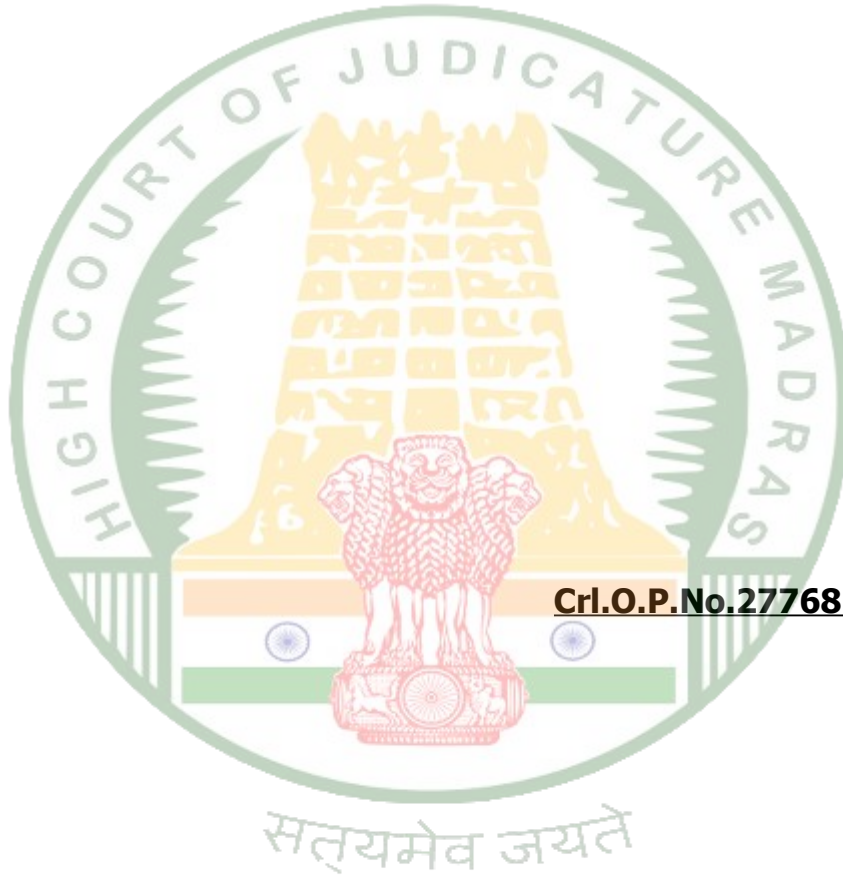
