The sentence passed against the petitioner in STC.No.1082 of 2015 dated 16.08.2017, by the learned Judicial Magistrate No.III, Salem and confirmed by the learned III Additional Sessions Judge, Salem, in C.A.No.113 of 2017 dated 05.10.2018, be suspended on condition that the petitioner shall deposit a sum of Rs.82,750/- to the credit of the above said Court within a period of four weeks from the date of receipt of a copy of this order.

2. If the deposit is not made within the time stipulated by this Court, the order of suspension of sentence shall stand automatically vacated without any further reference to this Court.

3. This miscellaneous petition is ordered accordingly.
