ORDER

This Writ Petition has been filed seeking for a direction to the first respondent to process the petitioner's Application No.2018/0103/03/119885 dated 01.11.2018 for Transfer of Patta within a time frame fixed by this Court.

The case of the petitioner is that he made an application dated 01.11.2018, before the first respondent, seeking transfer of patta in his name in respect of the properties in Survey Nos.97/2 and 98/1.
