2 The learned Additional Public Prosecutor on instructions would submit that the respondent police has completed the investigation and filed a closure report as "Further Action Dropped", before the XVII Metropolitan Magistrate Court, Saidapet, Chennai. The learned Additional

Public Prosecutor would further submit that now the jurisdiction has been changed to the VI Metropolitan Magistrate Court, Egmore, Chennai. Therefore, a direction can be given to the XVII Metropolitan Magistrate Court, Saidapet, Chennai to transfer the closure report already filed by the respondent police to the the VI Metropolitan Magistrate Court, Egmore, Chennai.

3 This Criminal Original Petition is disposed of, with a direction to the XVII Metropolitan Magistrate Court, Saidapet to immediately transfer the entire case records and the closure report in Crime No.56 of 2010 to the file of the VI Metropolitan Magistrate Court, Egmore. This exercise shall be completed within a period of four weeks from the date of receipt of a copy of this order.
