The Petitioner has filed this petition seeking to modify the condition imposed by this Court in Crl.O.P.No.23099 of 2018 dated 11.10.2018 for the offences punishable under 379 and 430 of IPC.

2.Heard the learned counsel for the petitioner.

3.In view of the above, the order made in Crl.O.P.No.23099 of 2018 dated 11.10.2018 is modified to the effect that the petitioner shall make a non-refundable deposit of Rs.5,000/- (Rupees Five Thousand only) through Bank Challan to the credit of the Chairman / District Collector, District Mineral Foundation Trust of the concerned District instead of demand draft. The time for executing the bond is extended by a further period of two weeks.

4.The other conditions in the order shall stand unaltered.
