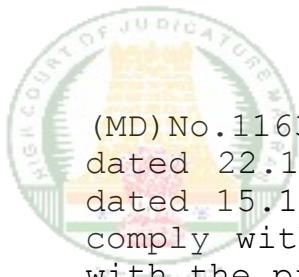

This petition is filed to extend the time granted to the petitioners in CRL MP(MD)No.11630 of 2017 in CRL OP(MD)No.15564 of 2017, dated 22.12.2017.

2. This Court, by order dated 15.11.2017 made in CRL OP(MD) No.15564 of 2017, granted anticipatory bail to the petitioners and directed them to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was made ready. However, the petitioners did not comply with conditions, within the time prescribed by this Court. Hence, they filed CRL MP
