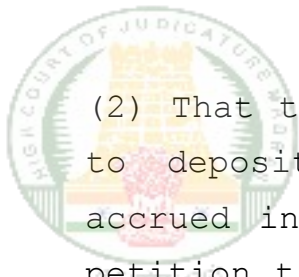

(3) That on such deposit being made, the claimants be and are hereby permitted to withdraw the same, without filling any application and

(4) That there be no order as to costs in this Civil Miscellaneous Appeal.
