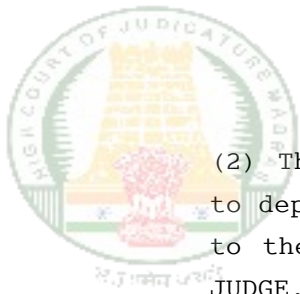
Prayer:-
