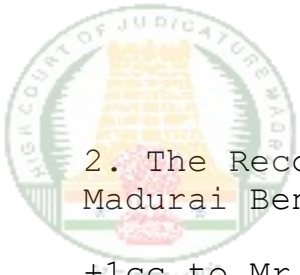
1.That the Award of the Tribunal below be and hereby confirmed and the Civil Miscellaneous Appeal is dismissed; and
