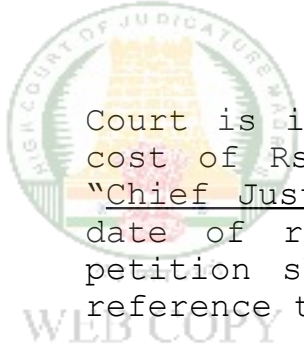
PRAYER IN CRP(MD) No.SR21152 of 2017:-
