PRAYER IN AS(MD)SR.NO.42815 of 2017 :

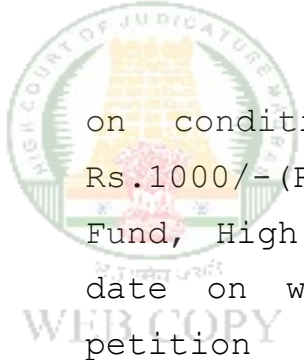
