PRAYER IN CMA (MD) No.SR3875 of 2018:

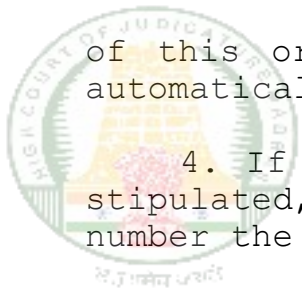
