PRAYER IN CMA(MD) No.SR44999 of 2017:

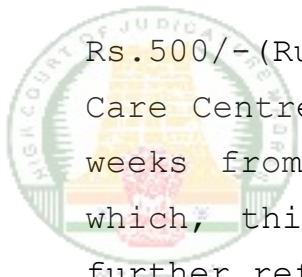
