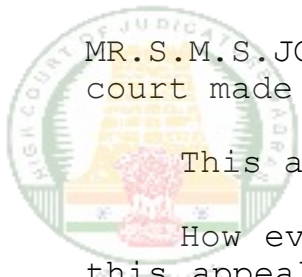
PRAYER IN WA (MD) No.SR6164 of 2018 :
