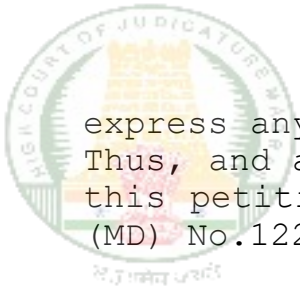
Prayer in CRP(MD)No.1226/2007 :
