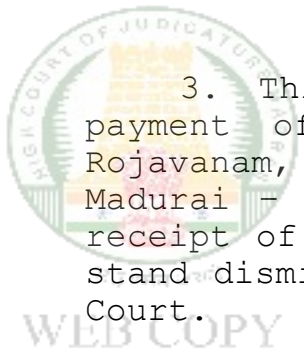
PRAYER IN CMA(MD) No.SR5407 of 2018:
