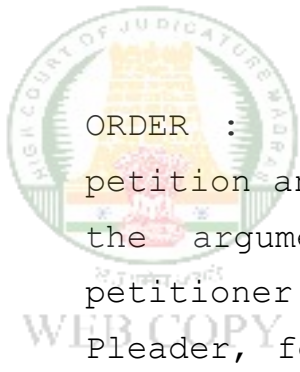

4. In view of the report of compliance, no further order is necessary in this matter.

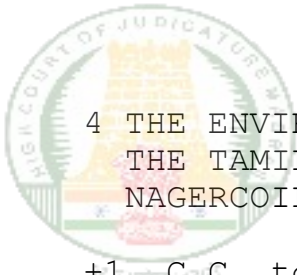
