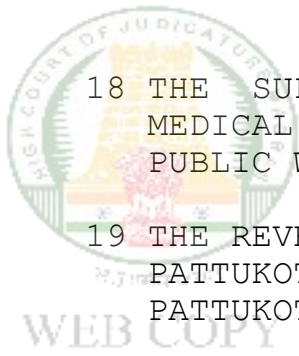

Prayer in MP(MD)No. 1/ 2015 in WASR(MD)No.22097/2014 :

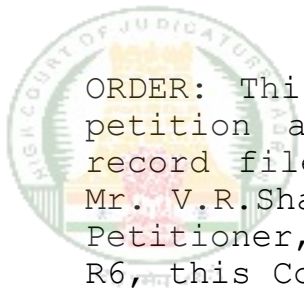

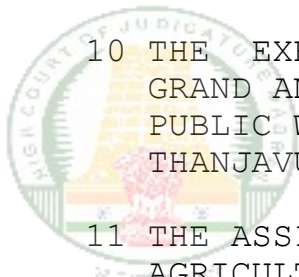
