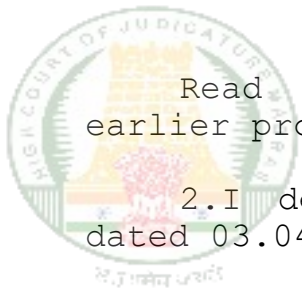
Prayer in CMP(MD)No. 1210 of 2017 :
