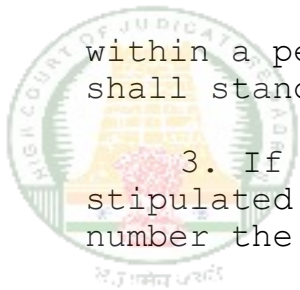
PRAYER IN CMA(MD) No.SR51519 of 2017:
