PRAYER IN CMA(MD) No.SR46550/2015:-

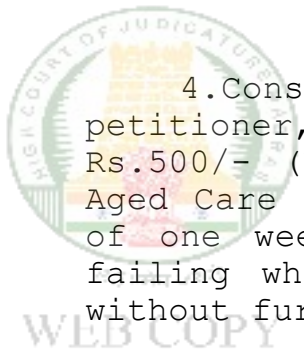
