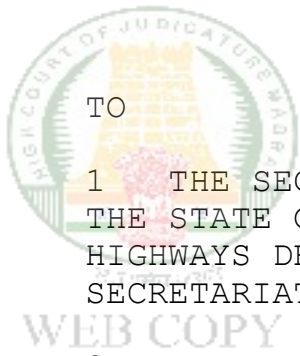
Writ Petition is filed Under Article 226 of the Constitution of
