Prayer in CRL OP(MD). 16716/ 2017 :

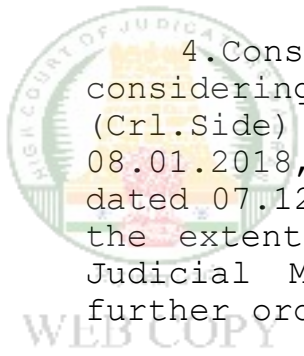
