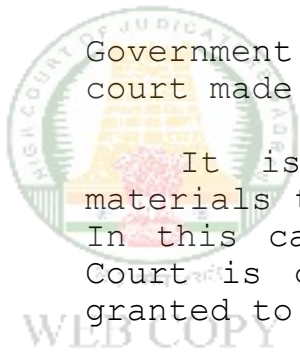
Prayer in CRL MP(MD). 1193/ 2018 IN CRL RC(MD) No.93 of 2018 :

Prayer in CRL MP(MD). 1193/ 2018 CRL RC(MD) No.93 of 2018:

To exempt the petitioners from surrendering in pursuance of judgment dated 25-01-2018 in C.A.NO.12 of 2016 on the file of Learned 1st Additional District and Sessions Judge, Thoothukudi.

Order : This petition coming on for orders upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.S.MUTHALRAJ, Advocate for the petitioner and of MRS.S.BHARATHY,



Government Advocate (Crl.Side) for R1 while admitting the Crl.Rc the court made the following order:-

It is seen that the appellate Court has found sufficient materials to convict and sentence the petitioners/appellants herein. In this case, the victim is a woman. In such circumstances, this Court is of the view that this is not a fit case in which the granted to the petitioners from surrendering.

Accordingly, these petitions are dismissed and the petitioners are directed the surrender and thereafter file a fresh petition for suspension of sentence. The Trial Court is directed to issue committal warrant.
