It is not the case of the defacto complainant that the conditions imposed by this court has been breached.

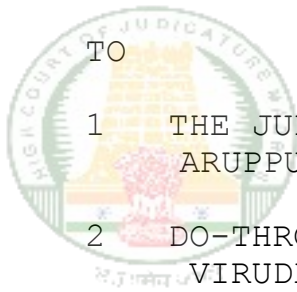
Hence, this cancellation petition is dismissed.
