The learned counsel appearing for the petitioners submitted that this Court, by order dated 22.01.2018 made in Crl.O.P(MD)No.887 of 2018, granted anticipatory bail to the petitioners and directed the petitioners to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was made ready. However, the petitioners did not comply with conditions, within the time prescribed by this Court. Hence, this present petition has been filed for extension of time.

3. Heard the learned Government Advocate (Criminal Side) on the said submission.

4. Considering the facts and circumstances of the case and the submissions made by the learned counsel appearing for the



petitioners, this petition is ordered and the time for executing the sureties is extended for a further period of two weeks from today.
