This Petition has been filed to modify the condition imposed by this Court in Crl.O.P.(MD)No.2008 of 2018, dated 08.02.2018.

2.The learned counsel appearing for the petitioner submitted that the petitioner is working as a Marketing Officer in Allahabad Bank at Trichy. Hence, it is very difficult for the petitioner to sign before the respondent police daily at 10.00 a.m for a period of three weeks. Hence, he prays to modify the condition.

3. Heard the learned Government Advocate (Crl.Side) appearing for the State.

Considering the facts and circumstances of the case and also considering the submission made by the learned counsel appearing for the petitioner, this Court is inclined to modify the condition imposed in Crl.O.P.(MD)No.2008 of 2018, dated 08.02.2018 to the extent that the petitioner shall appear and sign before the respondent police daily at 6.00 p.m., for a period of three weeks,



thereafter as and when required and time for executing the sureties before the concerned Magistrate Court is extended by one week from today.
