3.The learned Government Advocate (Crl.Side) appearing for the State submitted that the petitioner is complying the condition from 05.02.2018 to till date.

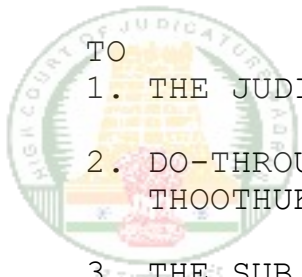
