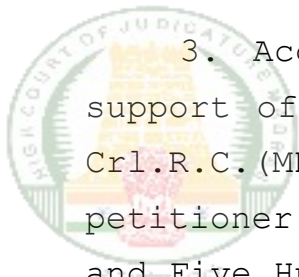
Prayer in CRL RC (MD) No.SR26920 of 2017:
