Prayer in CRL MP(MD) . 1456/ 2018 :

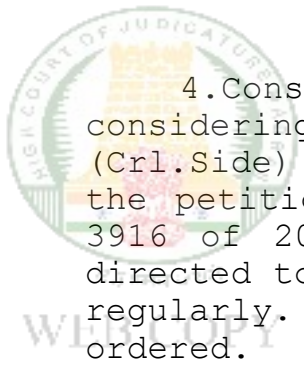
