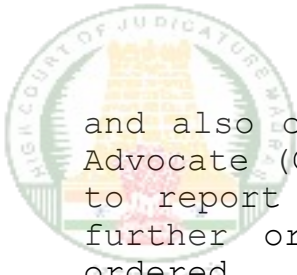
This Petition has been filed to relax the condition imposed in Crl.O.P(MD).No.591 of 2018, dated 12.01.2018.
