Prayer in CRL MP(MD). 166/ 2018 IN CRL OP(MD)No.5963/17 :

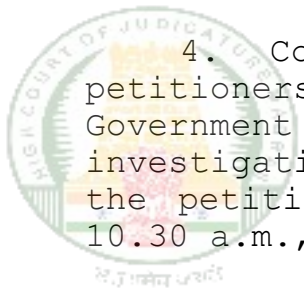
