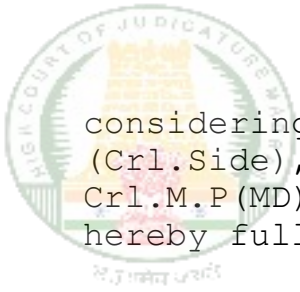
This Petition has been filed to relax the condition imposed in Crl.M.P(MD).No.17181 of 2017, dated 13.12.2017.
