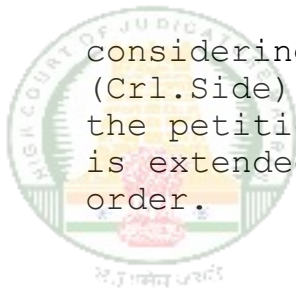
This petition has been filed to extend the time granted by this Court in Crl OP(MD)No.17543 of 2017, dated 20.12.2017, for executing the sureties.
