PRAYER in C.M.P.(MD).No.2114 of 2016: This Miscellaneous Petition filed under Section 5 of the limitation Act, to condone the delay of 274 days in filing the Writ Appeal in W.A.(SR).No.7621 of 2016.

PRAYER in W.A.(MD).No.SR7621 of 2016: This Writ Appeal filed under Clause 15 of Letters Patent, against the order of this Court passed in M.P.(MD).Nos.2 & 3 of 2014 in W.P.(MD).No.16547 of 2014 dated 16.04.2014.

Prayer in MP(MD). 2/ 2014 in WP(MD).16547/2014 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to Interim stay of all further proceedings in pursuant to the impugned notification dated 21.8.2014 in advertisement no.6/2014 issued by the 3rd respondent.

Prayer in MP(MD). 3/ 2014 in WP(MD).16547/2014 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to pass an order of Interim Direction directing the 3rd respondent to reserve one post for direct Recruitment Secondary Grade Teacher 2012-2013 as vacant for the petitioner pending disposal of the above WP.

Prayer in WP(MD). 16547/ 2014 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a writ of Certiorarified Mandamus to call for the records relating to the impugned notification dated 21.8.2014 in advertisement no.6/2014 issued by the 3rd respondent and quash the same in so far as the impugned notification of Adhi Dravida Welfare department vacancies and consequently direct the 3rd respondent to appoint the petitioner as Direct Recruitment Secondary Grade Teacher 2012-2013 .

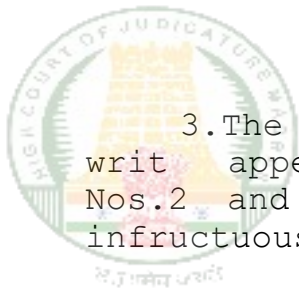
