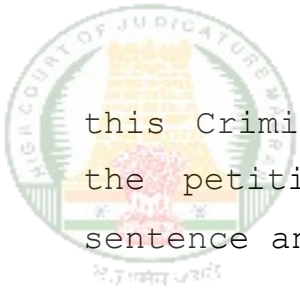

this Criminal Miscellaneous Petition is dismissed with liberty to the petitioner to surrender and apply for fresh suspension of sentence and bail.
