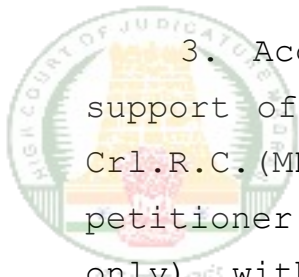
Prayer in CRL RC(MD) No.SR643 of 2018 :
