O R D E R

This petition is filed to quash the proceedings in C.C.No.2 of 2013 on the file of the learned Judicial Magistrate No.II, Dindigul as against the petitioners.

2.Perusal of the grounds raised by the learned counsel for the petitioners would show that there are no merits in the grounds raised by the learned counsel for the petitioners to quash the criminal proceedings against them.
