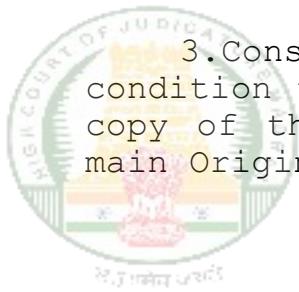
PRAEYR IN CRL OP(MD) No.SR1931 of 2018 :
