This Court, by order dated 05.01.2018 made in Crl.O.P(MD)No. 108 of 2018, granted anticipatory bail to the petitioner and directed the petitioner to appear before the concerned Magistrate, on or before 19.01.2018. However, the petitioner did not comply with the conditions, within the time prescribed by this Court. Hence, he has approached this Court with the present petition for extension of time.
