This petition is filed to extend the time granted to the petitioner in Crl.O.P(MD)No.12831 of 2017, dated 27.09.2017.

2.This Court, by order dated 27.09.2017 made in Crl.O.P(MD) No.12831 of 2017, granted anticipatory bail to the petitioner and directed the petitioner to appear before the concerned Magistrate, within a period of 15 days from the date on which the order copy was made ready. However, the petitioner did not comply with conditions, within the time prescribed by this Court. Hence, he has approached this Court with the present petition for extension of time.

3.The learned counsel for the petitioner contended that the petitioner could not produce the sureties within the time prescribed by this Court and hence, he prays for extension of time.

5.Considering the reasons stated in the affidavit filed in support of this petition, this petition is ordered and the



petitioner is directed to surrender before the Judicial Magistrate Court, Thirumangalam, Madurai District, within a period of one week from today and comply with the order dated 27.09.2017, made in CrI.O.P.(MD)No.12831 of 2017.
